

## Dog walking, Pet Sitting, and Boarding Waiver Form

I acknowledge that I bear exclusive responsibility for any harm resulting from my dog(s) during walks, pet sitting or boarding, or any interactions with Lisa (Pucci Villas). I willingly accept all associated risks, whether they are familiar or unfamiliar to me, resulting from my engagement in this service.

By entrusting my dog(s) to the care of Lisa (Pucci Villas), I affirm that Lisa (Pucci Villas) has considered my assertion that my dog(s) are in sound health and have not exhibited aggressive or menacing behavior towards any individuals or other dogs.

I comprehend that due to the natural way dogs interact with one another, minor cuts and scratches may happen, despite the vigilant supervision they receive at all times. Furthermore, Lisa (Pucci Villas) shall not be held accountable for any damage sustained to the dog's toys or belongings during their time in her care.

While my dog(s) is/are in the care of Lisa (Pucci Villas), if I cannot be reached in the event of an emergency, I grant authorization to Lisa (Pucci Villas), its agents, andrepresentatives to seek prompt veterinary care for my dog. I acknowledge my responsibility for any expenses associated with veterinary, medical, or other necessary treatment. I am mindful of the importance of possessing my own pet insurance.

I hereby release and absolve Lisa (Pucci Villas) and her assistants from any and all liability, including claims originating from Lisa/Pucci Villas, negligence, suits, actions, losses, injuries, or damages of any nature. This includes any liability, claims, suits, actions, losses, injuries, or damages sustained by me or my dog(s) regardless of their cause. I expressly agree to fully indemnify Lisa (Pucci Villas) and her representatives against all liability, claims, suits, actions, losses, losses, injuries, or damages.

Additionally, I acknowledge that if my pet were to injure another pet, I am solely responsible for any harm caused to my own pet or any other pets involved.

I certify that I have read and understand the rules and regulations set forth herein and that I have read and understand this agreement. I agree to abide by the rules and regulations and accept all the terms conditions and statements of this agreement and confirm the truthfulness of the contents of the application for completed by me.

While we thoroughly assess all our applicants and require a preliminary meet and greet, we recognize that this service may not be suitable for every dog. Therefore, Lisa (Pucci Villas) retains the authority to discontinue service for a dog at any point if deemed necessary.
